



Law & Economy Analytics is a joint initiative of academics whose objective is to advance our knowledge and engage in research for promoting a **sustainable and socially inclusive economy** in Turkey and the global level at large that **respects the economic, social and democratic rights of all working classes**.

A key **working hypothesis of the group** is our argument that without full recognition of workers' rights to organize and ensuring a fair and just distribution under decent jobs, conditions for participatory democracy cannot be ensured for the society at large. We rest our contestations on [David Harvey's seminal observation](#) that "*something significant has changed in the way global economy has been working since about 1970s*". As the late developing economies were brought into the "emerging market" status one by one, we witnessed the erosion of formal industrial relations together with marginalized conditions of work, hosting fragmented, unorganized and informal laboring precariat. Wherefore ***Analytics*** group's purpose is to cooperate with the parties actively involved in industrial relations to develop an awareness of effective industrial relations practices that will lead to a sustainable and socially inclusive economy.

Our Expertise: Led by a group of academics from **Kadir Has University**, Istanbul, the ***Analytics*** group promotes **inter-disciplinary** and **socially relevant research** in areas where economics, law, and political sciences command in **advancing structural conditions of decent jobs and social well-being**.
